**COMPLETE WORKY FREE INSTRUMENT PROTECTION PROGRAM**

This agreement is optional and not required. See the back of agreement for additional terms of the policy. In the event Lessee desires not to obtain the available coverage, Lessee will assume full responsibility for the care or replacement of the instrument and assumes all liability for loss or damage in the amount of the total payments stated above.

The following are NOT covered by this agreement:

1. Replacement of lost or damaged parts that do not affect the playing ability of the instrument.
2. Replacement of accessories, such as but not limited to: mouthpieces, reeds, reeds, bows, drumsticks, mallets, drum heads, strings, cymbals or broken bows, and bow hair.
3. Deliberate, malicious, or negligent damage as determined by N-TUNE MUSIC AND SOUND.

Coverage becomes void when the instrument is more than ten (10) days in arrears, and may be reinstated with current payment, and permission of N-TUNE MUSIC AND SOUND. Payment for Complete Worky Free Instrument Protection Plan in addition to the regular payment, and does not apply toward the purchase of the instrument. Assurances of the instrument protection plan allow the additional monthly charge to be added to the monthly rental payment.

REPLACEMENT: In the event of loss by FIRE or THEFT OF HOME BY FORCED ENTRY OR THEFT FROM VEHICLE BY FORCED ENTRY, N-TUNE MUSIC AND SOUND agrees to provide the Lessee with replacement of like quality and condition. The balance of the amount on the original instrument will be the responsibility of the Lessee, as amended to reflect the description of the replacement. Proof of
